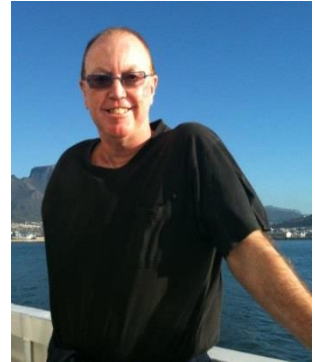

Australia Awards South West Asia – Train the Managers

In May, 2017, a professional development course was held in Bangkok, targeting the capacity building needs of Scope Global's country program managers and of DFAT's program managers at post in the South and West Asia region. Outcomes included:

- Enhanced participant ability to lead discussions and negotiations with partner government officials (linking development opportunities with aid investment priorities, public diplomacy dividends)
- Increased understanding of the modalities available through AASWA short-term activities (and ability to communicate these to partners)
- Ability to Identify the significant variables that influence the design of short courses


